EVERY ATTEMPT WILL BE MADE TO FULFILL YOUR REQUEST. HOWEVER, FINAL CLASS ASSIGNMENTS WILL BE MADE AT THE DISCRETION OF THE DIRECTOR.

Completed forms and the first tuition payment are due by July 15. If no payment is received by July 31, the child will be dropped from the program.

Notification of withdrawal for any reason must be received in writing by July 31. There will be no refund of the first tuition payment if notification is later than July 31.

The only exception to this policy would be in the case of pending admittance to another program or a job-related change. In this case, the office must be notified by July 15 that the student may withdraw before the beginning of the school year. We would then extend the refund date to August 15. To receive the refund, the office must be notified that the student is withdrawing by August 15. After August 15, there will be no refunds.

We reserve the right to cancel a class due to insufficient enrollment. Parents would be notified as soon as possible and no later than August 1. If this were to occur, all fees collected would be refunded to families.

Please be aware that the school may, at any time, have enrolled a child on a delayed immunization schedule and/or a student with a religious objection to immunizations.
